Philip Morris Art Awards 1995

THE National Art Gallery in Kuala Lumpur is currently featuring 83 art works selected from the 254 works submitted for the 1995 Philip Morris (Malaysian Level) Art Competition. This is the second time that the competition has been sponsored by the well-known multinational corporate group.

The first Philip Morris competition was held in 1994, signalling the multinational's active participation as a sponsor of the visual arts in this country and the Asean region. This Malaysian level affair is, in fact, part of a larger regional exercise involving all the Asean countries.

The separate national level competitions just concluded mark the first round endeavours towards the selection of the 30 Asean finalists who will take part in the 2nd Philip Morris Asean Art Awards 1995 exercise to be held in Jakarta in late August 1995. All the finalists will be invited to Jakarta and their works shown in an exhibition to be officially opened by the First Lady of Indonesia, Ibu Tien Suharto.

The judging for last year's Asean level competition took place in Singapore and all the works of the finalists were later shown at arts add vision, vitality and the Tressors 1995 Art Fair in Singapore. This year's finalists will also have their we benefit and contribute to works exhibited at Tressors 1995 in Singapore, thereby allowing for a wider exposure for Asean's creative artists. The Philip Morris group has been one of the major sponsors of the international Tressors art fairs in Singapore.

The Philip Morris Group of Companies, which has its headquarters in the US, describes itself as "the world's largest consumer goods company, manufacturing, marketing and selling more than 3,000 different products worldwide". Incidentally, they are also the people responsible for the very famous "Come to Marlborough county" advertisement

The Philip Morris Group of Companies has been a patron of the arts in the US and around the world for nearly 40 years, supporting the visual and performing




☐ FIGURE 5: Isaac by Wan Hui Jyu, 1995. Oil on canvas. 147cm x 152cm.

This year's Malaysian level competition drew 245 entries, a 32 per cent increase over last year's competition. The National Art Gallery has helped organise both last year's and this year's competition for the Philip Morris group.

The Malaysian level judges at this year's competition were artists Joseph Tan, Ponirin Amin, Wong Hoy Cheong and the National Art Gallery's acting director Wairah Marzuki. Incidentally, I will be serving as one of the three Asean level judges, working together with three other international judges at the final Asean level competi-

tion in Jakarta next month. The prize money for this year's national level com-

petition has been considerably enlarged — US\$25,000 (US\$1 = RM2.45) to be equally shared by the five winning artists. The five winners this time are Fauzan Omar, Puah Kok Yew, Hasnul Jamal Saidon, Rosli

Zakaria and Wan Hui Jvu (see illustrations).

Honourable Mention certificates were awarded to 22 other participating Malaysian artists. I have been told that all the five




☐ FIGURE 3: Magic Mirror on the Wall Free Me from the Poison of your Gaze by Hasnul Jamal Saidon, undated. Mixed media. 200cm x 90cm.
